BUSINESS TO BE DONE

1. Apologies.
2. Read and confirm minutes of last meeting Monday 8th July 2019.
3. Matters arising from the minutes: -
 - a) BL managed to get a grant from the British Heart Foundation (BHF) towards the cost of a defibrillator and training equipment, which has been delivered.
We now have to purchase an external heated defib' cabinet which cannot be locked. When installed we have to register it with the South West Ambulance Service and arrange a two hour training session in the parish hall for 8-10 people. (see items for payment for more information)
4. Clerks report.
 - a) Bank balances – Current A/C £5900.21. Deposit A/C £2764.01.
5. Items for payment:- £600 paid to the British Heart Foundation for a Defibrillator, (normal price £1100). plus Call, Push, Rescue (CPR) training equipment (worth about £400.)
We will have to pay approx' £550 for an external defibrillator cabinet, plus £150 + VAT to the South West Ambulance Service for training. The Parish Hall Committee have agreed to donate half of the above costs.

 - c) P19/09937/TCA:- The Old Rectory, Hydes Lane, Cold Ashton, S. Glos:- Works to crown lift to 4.5m 1 no. Box Elder and crown lift 2 no. Yew Trees by 205m. All situated within the Cold Ashton Conservation Area.
